The liquidated damage service charge will be billed on the 25th day of each month and any additional liquidated damage service charge, computed on the same basis, will be due and payable with the same terms specified above. Waiver of any one or more liquidated damage service charges shall not be deemed to be a waiver of future liquidated damage service charges. In the event that Standard commences litigation or employs attorneys in order to obtain payment of any sums due from Applicant, the Applicant agrees to pay for reasonable attorney fees and court costs in addition to all other sums due.
